

## VACATION SWEEPSTAKES OFFICIAL RULES

- No purchase necessary to enter or win. A purchase does not improve your chances of winning.** Open to legal residents of the US and Canada who are at least 21 years of age as of December 31, 2017. All applicable federal, state, and local laws and regulations apply. Employees of Signature Travel Network and their respective affiliates, suppliers, advertising agencies, and their families, and persons living in the same household as such employees, are not eligible to participate.
