

**Honor A Healthcare Hero
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. The Honor A Healthcare Hero Contest ("Promotion") begins at 8:00:00 AM Eastern Time ("ET") on May 7, 2020 and ends at 11:59:59 PM ET on July 31, 2020 ("Promotion Period"). *The promotion contains a contest of skill ("Contest"). The computer clock of Sponsor is the official time-keeping device in the Promotion.*

Completely enter the information requested in the form fields (required fields include: Nominator Full Name, Nominator Email Address, Nominator Phone Number, Nominee Full Name, Nominee Place of Employment – Company/Hospital Name and Address, Nominee Full Mailing Address, Nominee Phone Number, Nominee Email Address and Nominee Date of Birth). Once completing the registration form, you will then be asked to submit a 200-Word (or less) Essay Describing Nominee's Commitment to Serving Patients with Compassion and Supporting Colleagues Regardless of Personal Sacrifice. Upon completion of the registration form and submission of the essay, you will earn one (1) Entry into the Promotion. **Limit of one (1) Entry per person, per email address throughout the Promotion Period.** Upon submitting your Entry, you will have the option to share the Promotion with others.

 - Support of Colleagues (25%)
 - Personal Sacrifice (25%)
